The NHS Digital Information Governance Toolkit has now been replaced with the Data Security & Protection Toolkit. It allows organisations that process health and social care data to demonstrate their compliance with the GDPR and the National Data Guardian Data Security Standards. It will be used by the Care Quality Commission to monitor best practice.
